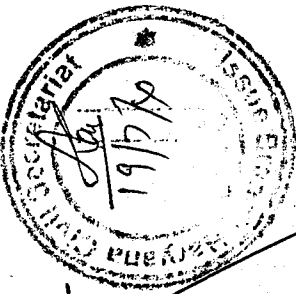



OFFICE MEMORANDUM

Subject: - Filling up of a post of the Director (Tea Promotion) Grade-I in the Tea Board's office at Moscow in the pay scale of Rs.12,000-16,500 (pre-revised) on "transfer on deputation" basis - regarding.

Tea Board, a statutory autonomous organisation under the Department of Commerce, Ministry of Commerce and Industry, Government of India, requires services of eligible and willing officers for appointment to the post of the Director (Tea Promotion) Grade-I in its office at Moscow in the pay scale of Rs.12,000-16,500 (pre-revised) on transfer on deputation basis, which has fallen vacant in April, 2010.

2. The scale of pay, number of posts, mode of recruitment, eligibility criteria and experience, job description and the period of deputation, etc. are given in **Annexure-I** attached to this Office Memorandum. The pay of the officer selected for appointment on deputation basis will be regulated in accordance with extant orders of Government of India on the subject in force from time to time.

3. It is, therefore, requested that the above vacancies may be circulated to all **Organisations under their administrative control** and the applications of suitable officers, who can be released in the event of their selection, may be forwarded through **proper channel** in the prescribed proforma in **triplicate** (as per the specimen given in **Annexure-II** attached to this O.M.), and a certificate as in **Annexure-III** along with (i) only photo copies of the Annual Confidential Reports (ACRs) of the applicants for the last five years duly attested by an Officer not below the rank of Under Secretary or equivalent (on each page with rubber stamp); (ii) a certificate from the employer that no disciplinary/vigilance case is either pending or being contemplated against the Officer; (iii) a statement indicating the details of major/minor penalties, if any, imposed on the officer during the last 10 years; (iv) Integrity Certificate duly signed by the competent authority; and (v) Cadre clearance, by name to **Shri K.K.Phill, Under Secretary, Plantation-A Section, Department of Commerce, Ministry of Commerce and Industry, Room No.510-A, Udyog Bhawan, New Delhi-110107** within sixty days from the date of publication of the advertisement in the Employment News. It may also be made clear that the officer, who volunteers for the post, will not be allowed to withdraw his/her candidature subsequently. Applications received after the last date or without confidential reports and other requisite documents or otherwise found incomplete will not be considered. Candidates whose applications have been received through proper channel with reference to the advertisement published in the Employment News 14-20 November 2009 and 30 January-5 February 2010 shall not apply again if their applications are complete in all respect.
