
In pursuance of Administrative Secretaries

the department in the C.M. Secretariat for reviewing  
by the Hon'ble Chief Minister, Haryana and Chief  
Secretary, Haryana.

You are requested to ensure compliance on  
all the above action points by 31<sup>st</sup> January, 2010.
