It has been brought to the notice of this Department that in several instances, the CPIOs while submitting their response on the RTI online Portal, enter brief remarks in the text box such as "Reply is attached" or "Reply has been given" etc. without actually uploading the corresponding documents. Similar issues have also been observed in case of uploading orders by the First Appellate Authorities. This leads to non availability of required information especially at the Second Appeal stage as RTI online portal has been integrated by NIC with the portal of CIC for Jetching data in respect of RTI replies and first appeals.
