Sir/Madam,

Haryana Government instructions bearing No. 22/132/2013-1GSIII, dated 22 March, 2022 vide which it was decided that the Scheduled Caste certificate, Deprived Scheduled Caste certificate, Backward Class certificate, Other Backward Class certificate, Tapriwas Caste certificate, Vimukt Jati (Denotified Tribes) certificate, Nomadic Tribes certificate Caste Certificate shall now be issued to eligible SARAL residents of Haryana based through the portal on PPN (https://saralharyana.gov.in/) facsimile signed by ADC-cum-DCRIO (Additional Deputy Commissioner-cum-District Citizen Resources Information Officer) or Head of the Department/Organisation, as the case may be.

These certificates will be issued on the basis of verified data on caste and income contained in the FIDR. The Standard Operating Procedures (SOP) for issuing Caste Certificates along with the formats of Caste Certificates shall be issued by the Citizen Resources Information Department.

Haryana Parivar Pehchan Authority has expressed that:-

i) Currently, the income verification process is underway and is about to complete in coming days. Without income verification it shall not be possible to issue backward Class/Other Backward Class certificates.

ii) In view of the difficulties faces by the applicant in this circumstance, it has become essential to continue with the procedure in place prior to these instructions till the time verification process is complete and the service is extended to all other caste certificates.

iii) Hence, a clarificatory instructions is required to be issued to the issuing authorities authorized under the procedure to continue issuing caste certificates other than the Scheduled Caste Certificate. And to the receiving entities in the State to accept the same as valid certificates till further orders.

These certificates will be issued on the basis of verified data on caste and income contained in the FIDR. The Standard Operating Procedures (SOP) for issuing Caste Certificates along with the formats of Caste Certificates shall be issued by the Citizen Resources Information Department.

Sh. Vikas Gupta, IAS Chief Executive officer Haryana Parivar Pehchan Authority (HPPA) has expressed that:-

- 1. Vide Government instruction No. 22/132/2013-1GSIII dated 22nd March, 2022, it was directed that all caste certificates shall be issued through the SARAL portal on provision of the PPN and from the effective date only such caste certificates shall be considered as valid.
- 2. Further, the service for issuing Scheduled Caste Certificates has been launched by the Hon'ble Chief Minister on 07th April, 2022.
- 3. Currently, the income verification process is underway and is about to complete in coming days. Without income verification it shall not be possible to issue backward Class/Other Backward Class certificates.
- 4. In view of the difficulties faces by the applicant in this circumstance, it has become essential to continue with the procedure in place prior to these instructions till the time verification process is complete and the service is extended to all other caste certificates.
- 5. Hence, a clarificatory instructions is required to be issued to the issuing authorities authorized under the procedure to continue issuing caste certificates other than the Scheduled Caste Certificate.
