Sir/Madam,

I am directed to invite your kind attention to this office letter of even number dated 15.05.2024 on the subject cited above vide which it was requested to provide the information regarding payment of wages to those persons working in different capacities asfield staff for discharging/performing duties on Saturdays and holidays due to exigencies attached to their services pertaining to their departments/boards/corporations/Municipal Bodies etc. within seven days positively through special messengers.

- 2. Despite elapse of more than 15 days, information from State Election Commission, MICADA, HARTRON, Anti Corrupotion. Bureau and Haryana Sechduled Castes Finance & Development Corporation Ltd.) only has been received and rest departments/boards/corporations/municipal bodies etc have not been provided information in this regard which amounts to violation of order of Chief Secretary to Government Haryana.
- 3. Hence, keeping in view of sensivity of matter, such lax attitute of Departments/Boards/Corporations/municipal bodies etc. has been viewed seriously by the Government and accordingly, now they are again directed to provide the requisite information within two days positively **through special messengers**. In case of failure, the Departments/Boards/Corporations etc. concerned itself will be responsible for such lapse and adverse orders from the Hon'ble High Court of Punjab and Haryana, if any.
- **4.** This may be taken on priority basis.
