Sir/Madam

I am directed to invite your attention towards this department's letter of even number dated 26.09.2023 on the subject cited above vide which a copy of letter No. spl/933/Liby.A.L2, dated 07.10.2023 received from Registrar General, Punjab and Haryana High Court, Chandigarh alongwith enclosures was enclosed with the request to provide the State Acts and Subordinate Legislation pertaining to their departments in pdf format as single file incorporating all amendments therein to the Legal Remembrancer & Administrative Secretary to Government Haryana, Law and Legislative Department, Haryana. And Law and Legislative Department was also requested supply the data further to the Registrar General, Punjab and Haryana High Court, Chandigarh after compilation of data received from the departments, so that same could be uploaded on India Code Portal (ICP).

2. Now, Registrar General, Punjab and Haryana High Court, Chandigarh has informed that information provided by Law and Legislative Department is not in the requisite form in which it was required (such as);

- To provide each Act Title wise (i.e. each Act in separate pdf) in English as well as in corresponding vernacular language as all the Acts received in English were supplied in single pdf.
- To provide complete Act(s) since some Acts (in Hindi version) were not complete as only preface page is available in the CD.
- To provide the amending Acts in English language also, similarly, supplied by Legal Remembrancer and Administrative to Government Haryana in Hindi Language.

3. In view of the above, Law and Legislative Department, Haryana has also expressed its inability to provide the information/data of Subordinate Legislation citing that the same is not maintained by them. So, they have also requested to review the matter and request all the Administrative Secretaries to provide the requisite information direct to the Registrar General, Punjab and Haryana High Court, Chandigarh in order to avoid delay in the matter.

4. Accordingly, the matter has been reconsidered by the Government and after detailed deliberation it has now been decided that the soft copies of local laws of Haryana in English as well as in corresponding vernacular language i.e. updated version of State Acts and Subordinate Legislations (rules framed thereunder) incorporating all amendments as a single file in pdf format may be provided by the departments direct to the Registrar General, Punjab and Haryana High Court, Chandigarh under intimation to this department.

5. Therefore, all the Administrative Secretaries and Heads of Departments are requested to direct the Nodal Officer of their department(s) appointed for this

purpose to provide the latest and updated version of State Acts and Subordinate Legislations incorporating all amendments therein as a single file in pdf format directly to the the Registrar General, Punjab and Haryana High Court. You are requested to provide the State Acts and Subordinate Legislation pertaining to their departments in pdf format incorporating all amendments as a single file to the Registrar General, Punjab and Haryana, High Court, Chandigarh within a week under intimation to this department. In case of any confusion or difficulty qua supplying information, Nodal Officer may be directed to approach the officer of Registrar General in person for clarity. In case of failure, the Head of Deptmt shall be personally responsible and same will be viewed seriously.

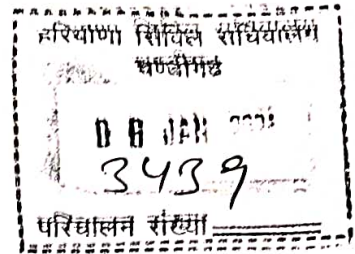

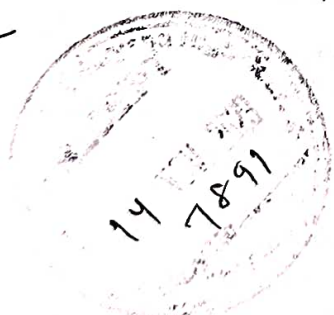
