Subject:- New scheme of Leave Travel Concession (LTC) for visiting Home Town and any place in India for the State Government Employees/Pensioners.

Sir/Madam,

I am directed to invite your kind attention towards State Government's letter of even number, dated 1st September 2023 on the subject noted above vide which LTC Block year 2020-2023 was extended by one year i.e. upto 31st December 2024 by the State Government.

2. Numerous clarifications are being sought from the Human Resources Department by various Department/Boards/Corporations/PSUs etc. as to whether next Block Year, i.e. 2024-2027, for LTC has commenced or not ?

3. Accordingly, it is hereby clarified that LTC for the Block Year 2020-2023 has been extended upto 31.12.2024 in respect of only those employees/pensioners who could not avail LTC during the enforcement of Block Year 2020-2023. It is further clarified that the next Block year i.e. 2024-2027, has commenced w.e.f. 01.01.2024 in the terms of State Government's letter No. 13/19/2008-2SII, dated 05.02.2009. The eligible employees/pensioners may avail fresh LTC of the Block year 2024-2027 during the current calender year provided they have not availed LTC of the previous block during the extended year.

4. This clarification may be brought to the notice of all concerned for information and necessary action.
