(i). The Deputy Commissioner shall give wide publicity to the above programme. He/she shall issue press notes and also paid advertisements in two local newspapers. He/she shall also make publicity through local cable network and local FM Radio.

(ii) The Deputy Commissioner shall publish the draft electoral rolls along with a notice including the dates by and the places where the claims and objections with reference to the draft rolls may be presented to the Revising Authority/Authorities on the date prescribed in sub-para (ii) of para 2 above,.

(vi) To facilitate electors and general public to obtain information regarding electoral rolls and to file claims and objections, the Deputy Commissioner concerned shall set-up sufficient number of Voters Information and Collection Centers (VICC) within the territorial limits of the Municipal Council. These Centers shall be fully equipped with computers and broadband internet connection. The Centers will be set up with the help of the National Informatics Center.

- (vii) Every claim and objection regarding distribution of electors ward wise shall be addressed and presented to the Revising Authority in the prescribed Form A and B, claims and objections can also be sent to the Revising Authority through registered post.
- (viii) Claim in Form-A shall be filed by those applicants, who intend to include their names, make correction in their entries or transposing of their names in another ward in the electoral roll.
- (ix) Objections in Form-B shall be filed by those applicants who intend to object inclusion of names or seek deletion of names from the electoral roll.
- (x) Only those persons can file their claims for inclusion of their names in the electoral rolls of a Municipal Council concered, whose name appear in the respective electoral rolls of legislative assembly constituency concerned, but do not appear in the draft electoral rolls published under rule 4 (3) of the Haryana Municipal Election Rules, 1978.
- (xi) The VICC will make available the prescribed forms, on demand free of cost, for filing claims and objections and receive the same for the consideration of and decision by the concerned Revising Authority or the officers authorized for this purpose. The forms shall also be hosted on the website of the District Administration for downloading and filing claims and objections.
- (xii) As and when any person files claim and objection, he/she shall be given a receipt in the prescribed format given in the form. An entry shall also be made in internet based monitoring system and manual registers.
- (xiii) The Deputy Commissioner shall appoint one Authorized Officer not below the rank of Group-B for maximum up to three wards and

sufficient number of supporting staff and other officials of the Municipal Council to assist the Revising Authority/Authorities to discharge his/her/their duty.

The Revising Authority/Authorities shall, after holding such enquiry into the claims or objections as he/she/they think(s) fit, record his/her/their decision in writing and shall make available forthwith a copy of such decision to the objector or claimant free of charge. Decision of the Revising Authorities shall also be hosted on the website for information of the public. Number of claims/objections accepted and rejected shall also be hosted on the website of the District Administration.

- The Revising Authority/Authorities after disposal of all the claims and (XV)objections in terms of under Rule 4 (4) (vii) of the Haryana Municipal Election Rules, 1978 shall forward a list of such claims and objections along with his/her/their orders thereon to the Deputy Commissioner . person aggrieved of any such order of the Revising Any Authority/Authorities may, within prescribed period, file an appeal to the Deputy Commissioner in prescribed format annexed as Annexure-E. The Deputy Commissioner shall within the specified time decide the appeal. Decision of the Deputy Commissioner on appeal shall be final. The rolls so amended shall be final and two copies thereof duly signed by the Deputy Commissioner and Revising Authority shall be kept in their offices together with list of additions and corrections.
- The Deputy Commissioner shall publish the final electoral rolls on (xvi) 28.01.2025, which shall come into force from the date of its publication.
- (xvii) After completion of every stage of up-gradation of electoral rolls process as stated above, the Deputy Commissioner concerned shall send information in the format given in Annexure "B" and "C" to the Commission.

It is further directed that one set of the electoral rolls of Legislative Assembly constituency concerned alongwith all supplements updated by the Election Commission of India up to the date of publication of this notification, may be obtained free of cost from the office of the Chief Electoral Officer, Haryana, Chandigarh or the Election Tehsildar/Election Naib Tehsildar concerned. Database of the electors included in relevant part of the Legislative Assembly constituencies has been supplied to the District Informatics Officer of your district through NIC, Haryana Chandigarh.

4.

It is further directed that :-

- (i) The Deputy Commissioner concerned shall give wide publicity to the above programme. He/she shall issue press notes and also paid advertisements in two local newspapers. He/she shall also make publicity through local cable network and local FM Radio.
- (ii) The Deputy Commissioner concerned shall publish the draft electoral roll along with a notice including the dates by and the places where the claims and objections with reference to the draft rolls may be presented to the Revising Authority/Authorities on the date prescribed in sub-para (ii) of para 2 above.

(iii)

One copy of the draft list of electoral roll published for inviting claims and objections, shall be kept for inspection of the public free of cost at the following places:-

a. Office of the Deputy Commissioner concerned.

b. Office of the Municipal Corporation concerned.

c. Office of the Sub-Divisional Officer (Civil) concerned.

d. Tehsil Office concerned.

e. Office of the Revising Authority/Authorities and

f. Voter Information and Collection Centers (VICCs)

(iv)

After draft publication of ward-wise electoral rolls, the same should also be hosted on the website of the District Administration with search facility.

- A copy of the draft electoral rolls and final electoral rolls along (v) with database in compact disc duly signed by the Revising Authority/Authorities shall be kept in a sealed cover in the Treasury concerned within 24 hours from the date of publication of draft and final electoral rolls, respectively.
- In order to facilitate electors and general public to obtain (vi) information regarding electoral rolls and to file claims and objections, the Deputy Commissioner shall set-up sufficient number of Voters Information and Collection Centers (VICC) within the territorial limits of the Municipal Corporation . These Centers shall be fully equipped with computers and broadband internet connection. The Centers will be set up with the help of the National Informatics Center.
- Every claim and objection regarding distribution of electors ward (vii) wise shall be addressed and presented to the Revising Authority in the prescribed Form A and B, claims and objections can also be sent to the Revising Authority through registered post.
- Claim in Form-A shall be filed by those applicants, who intend to (viii) include their names, make correction in their entries or transposing of their names in another ward in the electoral roll.
- Objections in Form-B shall be filed by those applicants who (ix)intend to object inclusion of name(s) or seek deletion of name(s) from the electoral roll.
- Only those persons can file their claims for inclusion of their (X) names in the electoral rolls of a Municipal Corporation concerned, whose name appear in the respective electoral rolls of Legislative Assembly constituency concerned, but do not appear in the draft electoral rolls published under rule 4 (3) of the Haryana Municipal Corporation Election Rules, 1994.

The VICC will make available the prescribed forms, on demand (xi)free of cost, for filing claims and objections and receive the

same for the consideration of and decision by the concerned Revising Authority or the officers authorized for this purpose. The forms shall also be hosted on the website of the District Administration for downloading and filing claims and objections.

(xii)

As and when any person files claim and objection, he/she shall be given a receipt in the prescribed format given in the form. An entry shall also be made in internet based monitoring system and manual registers.

(xiii) The Deputy Commissioner concerned shall appoint one Authorized Officer not below the rank of Group-B for maximum up to three wards and sufficient number of supporting staff and other officials of the Municipal Corporation to assist the Revising Authority/Authorities to discharge his/her/their duty.

(xiv) The Revising Authority/Authorities shall, after holding such enquiry into the claims or objections as he/she/they think fit, record his/her/their decision in writing and shall make available forthwith a copy of such decision to the objector or claimant free of charge. Decision of the Revising Authorities shall also be hosted on the website for information of the public. Number of claims/objections accepted and rejected shall also be hosted on the website of the District Administration.

(xv) The Revising Authority/Authorities after disposal of all the claims and objections in terms of under Rule 4 (4) (vii) of the Haryana Municipal Corporation Election Rules, 1994 shall forward a list of such claims and objections along with his/her/their orders thereon to the Deputy Commissioner. Any person aggrieved of any such order of the Revising Authority/Authorities may, within prescribed period, file an appeal to the Deputy Commissioner in the prescribed format annexed as Annexure-D. The Deputy Commissioner shall within the specified time decide the appeal. Decision of the Deputy Commissioner on the appeal shall be final. The rolls so amended shall be final and two copies thereof duly signed by the Deputy Commissioner and Revising Authority

shall be kept in their offices together with the list of additions and corrections.

- (xvi) The Deputy Commissioner concerned shall publish the final electoral rolls on **28.01.2025**, which shall come into force from the date of its publication.
- (xvii) After completion of every stage of up-gradation of electoral rolls process as stated above, the Deputy Commissioner shall send information in the format given in Annexure "B" and "C" to the Commission.

5. It is further directed that a copy of ward wise electoral rolls thus prepared of the concerned Municipal Corporation will be finally published on **28.01.2025**. In addition, a copy of the updated electoral rolls along with a CD (compact disc) containing database of the same in PDF format without photographs shall be sent to all the political parties in the State of Haryana on the same day under intimation to the Commission.

6. It is further directed that the final electoral rolls of the Municipal Corporation concerned shall be hosted on the website of the District Administration on the day of its publication.


