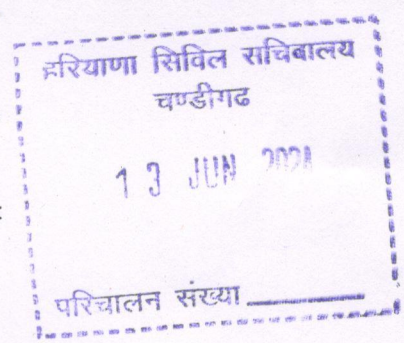

Sub:- Invitation of applications for the post of Chairperson, Rajasthan Electricity Regulatory Commission (RERC).

Sir,

The Rajasthan Electricity Regulatory Commission (RERC) was set up in 1999 under Section 17 (1) of the Electricity Regulatory Commissions Act, 1998 (Act No. 14 of 1998) and continues as such for purposes of the Electricity Act, 2003.

The tenure of present Chairperson of the Commission is going to complete on 31.07.2024. It is proposed to fill up this vacancy. Appointment to the post of Chairperson of the Commission is governed by the relevant provisions of the Electricity Act, 2003.

Section 84 of the Electricity Act, 2003 inter alia states that, the Chairperson of the State Commission has to be person of ability, integrity and standing who has adequate knowledge of, and have shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. It has further been prescribed that the Chairperson of the State Commission shall not hold any other office.

As provided under Section 89(1) of the Electricity Act, 2003, the Chairperson shall hold office for a term of five years from the date he/she joins office. Provided further, that Chairperson shall not hold office as such after he/she has attained the age of sixty five years. The candidate will have to give a declaration that he/she does not have any financial or other interest, which is likely to affect prejudicially his/her functions as Chairperson, Rajasthan Electricity Regulatory Commission.

The terms of appointment shall be in accordance with the provisions of Electricity Act, 2003 including the person appointed shall have to resign or opt for voluntary retirement from the services or organization to which he/she belongs.

The salary, allowances and other conditions of the service of the Chairperson, RERC shall be governed under Rajasthan Electricity Regulatory Commission (Salary, Allowances and other conditions of service of Members) Rules, 1999 and as amended from time to time.

The Chairperson shall receive a pay of Rs. 2,25,000/- per month fixed (minus pension including the commutation portion drawn from previous services, if any, where the Chairperson is a retired officer). In case the Chairperson, if appointed from non-officials, he shall be allowed salary as prescribed above. In case the Chairperson is appointed from the officials retired from the service of the State Government, he shall be allowed salary as last pay drawn minus pension. The Chairperson would be entitled for Dearness Allowance as admissible to the corresponding grade officers of IAS in the State. The Chairperson who is living in his own house would get HRA as admissible to the corresponding grade officers of IAS in the State. In case of rental accommodation, actual reimbursement of HRA will be admissible subject to maximum 18% of the Basic Pay. The Chairperson of the Commission shall be provided with a staff car and a driver. He/she shall be entitled to use Commission's vehicle for the journeys performed from his/her residence to office and back on the same charges as payable by corresponding grade officers of Indian Administrative Services in the State. A car allowance of Rs. 15750/- plus Dearness Allowance thereon would be provided, if he/she make his/her own transport arrangements.
