

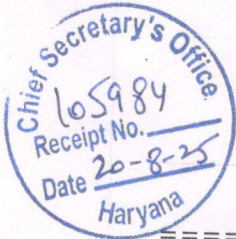

Subject: Filling up the post of Member (Traffic & Logistic), Inland Waterways Authority of India (IWAI), Noida, an autonomous body under this Ministry, in level-14 of the 7th CPC Pay Matrix (Pre-revised pay scale of Rs. 37,400-67,000/- with Grade Pay of Rs. 10,000/-) on Deputation basis.

Applications are invited for one vacant post of Member (Traffic & Logistic) in the Inland Waterways Authority of India (IWAI), NOIDA, Uttar Pradesh on Deputation basis. The Post is in the Level-14 of the 7th CPC Pay Matrix (Pre-revised pay scale of Rs. 37,400-67,000/- with Grade Pay of Rs. 10,000/-). The terms of deputation of Member (Traffic & Logistics) will be initially for a period of three years, which is extendable upto five years.

2. The Member (Traffic & Logistic) will be responsible for:

- (i) Marketing and Promotion of Inland Waterways Transport (IWT) activities;
- (ii) Development of project for transportation of IWT on National Waterways and follow up thereof.
- (iii) Preparation and implementation of IWT promotional schemes.
- (iv) Rendering commercial advice to run the organization on business Principle.
- (v) Any other responsibility assigned by Chairman, IWAI.

3. As a Member of the Authority, Member (Traffic & Logistics) will be entitled for accommodation as per IWAI Rules, 1986.

4. The applicants fulfilling the following eligibility criteria may apply for the post of Member(Traffic and Logistics):-

A. Essential Eligibility Criteria:

(i) **Age:** Not exceeding 55 years on the closing date of receipt of application.

(iii) Qualification and Experience:

Officers belonging to All India Service or Central Civil Service (Group A) holding analogous post in level -14 of the Pay Matrix of 7th CPC (Pre-revised pay scale of PB-IV of Rs. 37,400-67000/- + Grade Pay Rs. 10,000/-), **Or**

(Officers of All India Service or Central Civil Services (Group A) with 5 years' service in level 13 of 7th CPC (Pre-revised pay scale of PB-IV of Rs. 37,000 - 67000/- + Grade Pay Rs. 8,700/-)

B. Desirable Eligibility Criteria:

(i) Preference will be given to the officers having experience in at least one of the sectors viz. Inland Water Transport Sector, Shipping, Ports, Railways, Roads, Logistics or related sectors.

(ii) Cooling off period as per the DOP&T's guidelines.

5. It may also be noted that in the event of selection, the concerned officer will not be permitted to withdraw his candidature.

6. It is requested that the vacancy may be given wide circulation among various cadres and applications in respect of willing and eligible officers, who could be spared immediately in the event of their selection, may be forwarded in the enclosed format along with following documents:




