Respected Ma'am/Sir,

As you are aware, Mid-Career Training Programme (MCTP) for IAS Officers was introduced in 2007 with the objective of strengthening 'next level Competencies' at identified stages of their careers.

- 2. The IAS Pay Rules 2016, prescribe the completion of the mandatory MCTPs as a prerequisite for granting career benefits. In order to ensure a balance between these mandatory provisions and the difficulties faced by the Cadre Controlling Authorities in relieving the officers due to administrative exigencies, each officer is allowed three chances to complete each phase of MCTP.
- 3. During the course of review of the MCTP with Lal Bahadur Shastri National Academy of Administration (LBSNAA), it was observed that there are large number of eligible officers who have not undergone training due to various reasons.
- 4. The 19th round of Phase IV mandatory MCTP for IAS officers is scheduled from 06th January to 31st January, 2025 at LBSNAA Mussoorie.
- 5. The current round of Phase IV training is being offered to the officers indicated below:
 - (i) Officers of 2010 batch (1st chance)
 - (ii) Officers of 2009 batch (2nd chance)
 - (iii) Officers of 2008 batch (3rd chance)
 - (iv) Decision on participation of residual officers up to 2007 batches (who have availed of 03 opportunities or more already) will be taken based on the merits of each case by this Department.
- 6. An officer who has less than three years of services after the year in which he/she has been slotted to undergo the Phase-IV of the MCTP would not be sent for the training and, therefore, the officers who are retiring before 31.12.2028 shall not be nominated for the current Phase IV training programme.
- 7. A list of the officers falling in the eligibility zone (i.e. after deleting the names of the officers who are superannuating before 31st December, 2028), as per our database, is attached. Any discrepancy in this list may kindly be brought to the notice of Training Wing, Department of Personnel and Training, Govt. of India, for corrective action.
