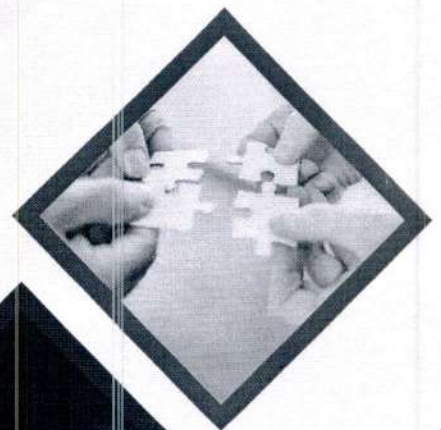

Day 1

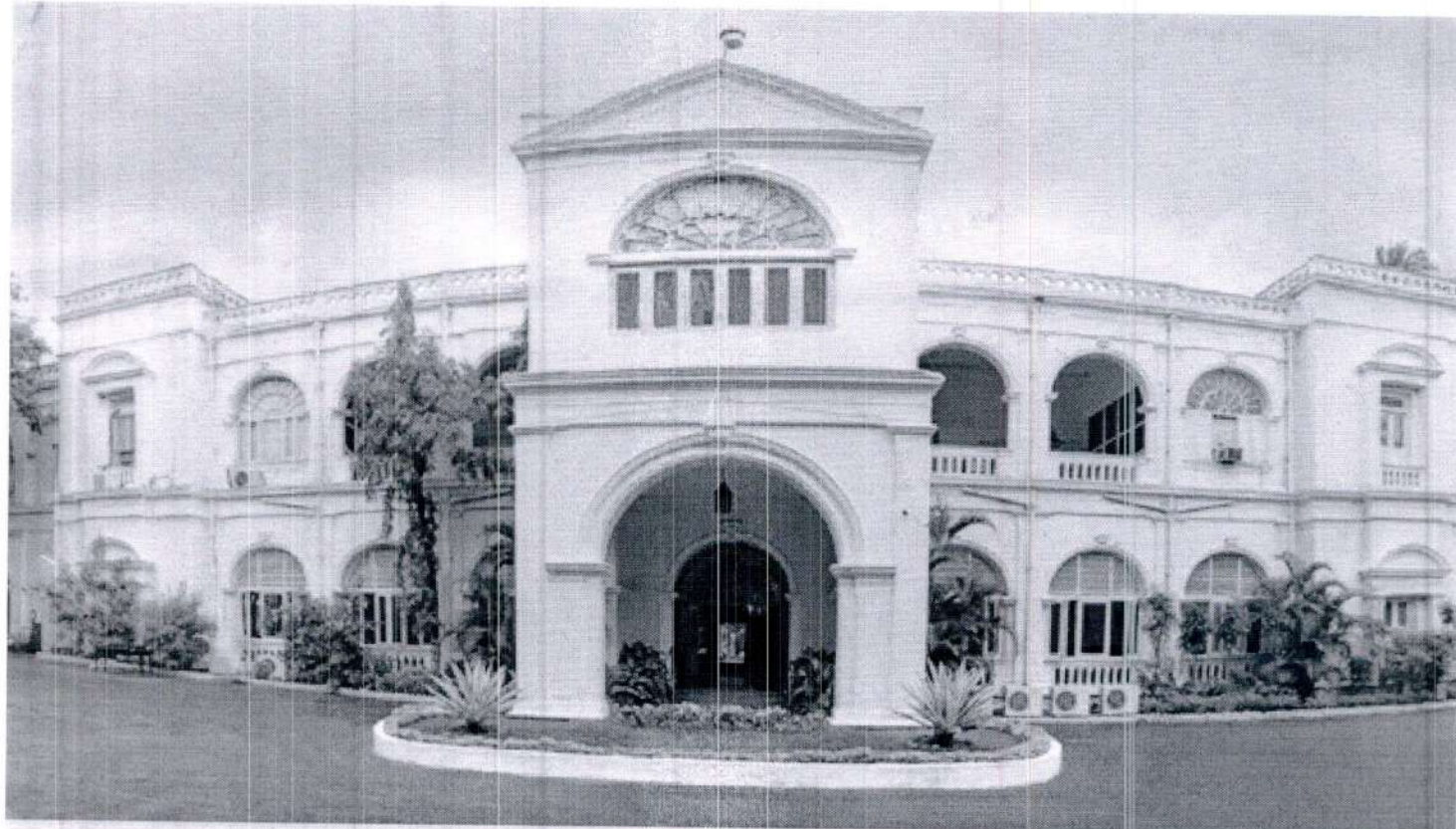
