Subject: Implementation of Content Management Framework (CMF) in all Government websites.

Dear Administrative Secretary,

This is to bring to your personal attention that the Hon'ble Supreme Court of India vide its judgment dated 15.12.2017 passed in WP(C) No. 243 of 2005 has directed to ensure compliance with the AIC (Accessible India Campaign) deadline of making at least 50% of Central and State Government websites and public documents compliant with accessibility standards by March 2018. This judgment seeks to enforce the provisions of "Rights of Persons with Disabilities Act 2016" which came into force on 19th April 2017 and mandates that the Web content be usable to a wider range of people with disabilities, including blindness and low vision etc.

In order to comply with the orders of Hon'ble Supreme Court of India the Govt. of India has initiated the Content Management Framework (CMF) project with a view of standardization and improvement in presentation and content delivery of websites of Government Departments. The Department of empowerment of persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Gol has entrusted M/s R V Solutions Pvt. Ltd. with the responsibility of redesigning websites of the Government departments as per Web Content Accessibility (WCAG 2.0 (A, AA)) and Guidelines for Indian Government Websites (GIGW).

In the first phase, 69 websites of Haryana Government departments have been taken up. The summary status of various Haryana Government websites along with steps involved in redesigning these websites, activities required at the end of the departments and contact person details are enclosed.

Your department is yet to give initial approval to the RV Solutions Pvt. Ltd. to go ahead with the work of redesigning of the official website of your department. Therefore, required approval should be granted. After getting the website of your department developed as per GIGW/WCA2.0 through RV Solutions Pvt. Ltd. the department should ensure to keep the website updated on day to day basis and ensure to upload the bilingual (Hindi) contents to the website through Web Information Manager of your department.

The Steps to be followed, summary status of 69 Haryana Government websites undertaken by M/s R V Solutions Pvt. Ltd., Activities to be done by the departments and contact details:

[A] Sequence of Steps followed for making the website WCAG2.0/GIGW compliant :

- Step - 1 : Website allotted to RV Solutions .**
- Step - 2 : Approval from owner Department .**
- Step - 3 : Designing of website .**
- Step - 4 : Approval of the design from owner department .**
- Step - 5 : Complete content migration to new website .**
- Step - 6 : UAT (User Acceptance and Testing).**
- Step - 7 : Security audit and testing .**
- Step - 8 : Signing of Website Quality Manual (WQM) by the owner department.**
- Step - 8 : Hosting / Go Live**

A Workshop for the sensitization of the departments whose websites is to be taken up for redesigning in first phase was organized on 24.04.2017 at Knowledge Centre.

[B] The summary of work done on 69 websites as on 11/01/2018 is given as under:

[C] Details of activities to be performed by the department:

1. Provide the work and technology (Drupal or DNN) approval immediately.
2. Approve the Design of the website within 3 days of receiving the design template.
3. Designate a Web Information Manager (WIM)/Website Nodal Officer of the department.
4. Provide bilingual content to the R V Solutions Pvt. Ltd.
5. Provide User acceptance and Testing (UAT) approval within 3 days of development of the website.
6. Approve the Website Quality Manual (WQM) within 3 days of receiving it. This will be provided by R V Solutions Pvt. Ltd. to the department after completion of the website.
7. Coordinate with hosting agency (NIC) to deploy the website on their server.
