CIRCULAR

It is proposed to fill up the posts of Principal Private Secretary, Section Officer & Assistant as per details listed in Annexure-I in the Northern Regional Office at Chandigarh of the Ministry of Environment, Forests & Climate Change from amongst officials of Central/Central Govt. PSU's /State Government Departments on ad-hoc deputation. Qualification required for each of the posts can be seen at Annexure-II.

The terms & conditions of the candidates selected for appointment on deputation basis will be governed as per the conditions laid down in the Government of India, Department of Personnel and Training O.M. No. 6/8/2009-Estt. dated 17.6.2010 and MoEF&CC letter No. 6-1/2014-ROHQ dated 1.7.2015 as amended from time to time.

The period of deputation will be initially for two years and is likely to be extended further. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other office/department of the Central Government shall ordinarily not exceed three/four* (3/4*) years. The maximum age limit for appointment of deputation shall not exceed 56(fifty six) years as on the closing date prescribed for receipt of application.

Applications of officials who are eligible and are willing to be considered for appointment on deputation basis who can be relieved immediately after selection may be forwarded through proper channel along with their self attested copies of ACRs for the preceding five (5) years, cadre clearance, vigilance clearance, integrity certificate and certificate to the effect that no minor/major penalty has been imposed on the officer during the last ten years, so as to reach the Head of Office, Ministry of Environment, Forest & Climate Change, Northern Regional Office, Bays No. 24-25, Sector-31A, Chandigarh-160030.

The receipt of complete application form in the prescribed format for deputation posts should reach this office within 45 days from the date of publication in the newspaper (The Tribune). Applications without the recommendation of the parent Office/Department, incomplete applications or applications received after the prescribed date or without ACR dossiers/Vigilance Clearance will not be entertained.
