Subject: Revised information regarding Group D employees of ESP Quota whose services have been terminated in the absence of Sports Gradation Certificate.

Sir/Madam,


I am directed to invite your attention to the subject cited above and to inform that in compliance of decision of Hon'ble High Court in LPA 1332/2019, vide instructions No. 42/09/2019-4GS-I, dated 10.11.2020, it was directed that all the candidates, whose appointment was subject to final outcome of above said LPAs and the candidates who have not yet been allowed to join duty due to non-availability of the Sports Gradation Certificate issued in terms of the new Sports Policy dated 25.05.2018, they would produce the appropriate Sports Gradation Certificates to their Appointing Authorities before 31.12.2020 otherwise their appointment/selection would be terminated immediately by the Appointing Authority under intimation to the Government and HSSC. All departments/boards/corporations were also directed vide letter No. 42/09/2019-4GS-I, dated 06.01.2021, 15.01.2021 & 28.01.2021 to inform regarding Group D employees whose services have been terminated in the absence of Sports Gradation Certificate.

2. It has come to notice that some of the Group-D employees of ESP Quota have got stay order from the Hon'ble High Court against the termination order, as a result of which the revised status report is required to take further necessary action in the matter.

3. In view of above, all the Heads of Departments/Boards/Corporations (list attached) are requested to send their revised status report of such candidates of ESP Quota whose services have been terminated due to non-production of Sports Gradation Certificate in the following performa to GAD (General Services-I Branch) through e-mail at generalservices0001@gmail.com and also through special messenger by 26th February, 2021 positively:-
