Subject:- Haryana Government Employees New Group Insurance Scheme, 1985. Table of benefits for the savings fund for the period from 01-04-2015 to 31-03-2016.

Sir,

I am directed to invite your attention to Haryana Government letter No.4/3/97-3NGIS, dated 07-05-2014, on the subject noted above and to forward herewith tables of benefits for the saving fund of the revised and unrevised scheme under New Group Insurance for the year 2015-2016. Now the tables of benefits for the saving fund of the scheme based on a subscription of Rs.10/- per month from 01-04-1986 to 31-12-89 and Rs.15/- per month w.e.f. 01-01-1990 onwards have been prepared for the year 2015-2016 and a copy of the same is enclosed. Another table of benefits for the saving fund based on a subscription of Rs 10/- per month for those employees who had opted out of the revised rates of subscription w.e.f. 01-01-1990 have also been drawn up for the year 2015-2016 and a copy of the same is also enclosed for your guidance and compliance thereof. The amount in the tables have been worked out on the basis of interest @ 10% per annum (compounded quarterly) w.e.f. 1.04.1986 to 31.03.1987 and 12% per annum (compounded quarterly) w.e.f. 01-04-1987 to 31-03-2001, 11% per annum (compounded quarterly) w.e.f. 01-04-2001 to 31-03-2002, 9.5% per annum (compounded quarterly) w.e.f. 01-04-2002 to 31-03-2003, 9% per annum w.e.f. 01-04-2003 to 31-03-2004, 8% per annum (compounded quarterly) w.e.f. 01-04-2004 to 30-11-2011, 8.6% per annum (compounded quarterly) w.e.f. 01-12-2011 to 31-03-2012, 8.8% per annum (compounded quarterly) w.e.f. 01-04-2012 to 31-03-2013 and 8.7% per annum (compounded quarterly) w.e.f. 01-04-2013 onwards. The mortality rate under the scheme has been taken as 3.75 per thousand per annum upto 31-12-87 and 3.60 per thousand per annum thereafter in both cases. While calculating the amounting it has been assumed that the subscription has been recovered or will be recovered from the salary of the month in which a member ceases to be in service failing which it should be deducted from accumulated amounts payable.
