Subject: Compliance of order of Hon'ble High Court – Ravinder Singh vs State of Haryana and others.

Vide its orders dated 26.08.2017 the Hon'ble High Court of Punjab and Haryana in CWP No. 19086 of 2017 (O&M), interalia, has passed the following orders:-

“The Deputy Commissioners in the States of Haryana and Punjab shall invite applications/claims regarding damages caused to public and private properties which shall be verified and forwarded to this Court through the offices of Advocate Generals, Punjab and Haryana.”



You are, therefore, directed to invite applications/claims about the damages caused to public and private properties during the agitation/riots caused by the followers of Dera Sacha Sauda recently. A copy of the application form for claim of damaged property is enclosed.

You are, further, directed to give wide publicity through media as well as internet to the contents of the applications and give at least 15 days time to the claimants to submit their claims to a Nodal Officer preferably Additional Deputy Commissioner of your district. All the claims/applications may be scrutinised and their content may be verified by a Committee of the competent officers within next 7 days. A report alongwith your specific recommendation may be sent to the Chief Secretary to Government Haryana (in Political & Parliamentary Affairs Branch) within next 3 days after verification.

Regarding Public/Govt. property, you are directed to take an appropriate claim from each head of the office of the various departments, boards, corporations, other public organizations located in your district. Such a claim may also be taken from private persons if they want to lodge it.

You may also publicize the ticker running on the website www.haryana.gov.in. It will facilitate the applicants & heads of office in lodging their claims.

1. Proof of ownership of affected property/tenancy (if applicable).
2. Photographs of the damaged property.
3. Copy of First Information Report (FIR)/DD entry.
4. Copy of Aadhar Card.
5. Copy of insurance and Registration Certificate of Vehicle.
6. Self-declaration from the affected person that he has not availed any other assistance for loss from any other Government/Public Agency/Insurance Company.
