



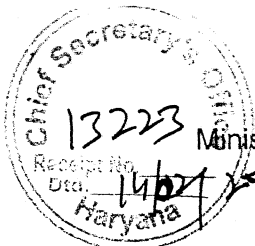

Accordingly, para 1.1 of the Consolidated Deputation Guidelines for All India Service officers are hereby substituted by following provisions:-

1.1 Central Staffing Scheme:-

Posts that are to be covered:

Ministries/Departments of Government of India, Union Public Service Commission, Election Commission of India, Central Vigilance Commission and Central Information Commission.

Procedure to be followed for appointment:

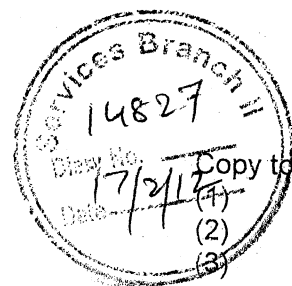
Civil Services Board (JS and below), with ACC approval for JS and above

Tenure to be applicable:

US level	-	3 years
DS level	-	4 years
Dir level	-	5 years
JS level	-	5 years
JS/AS level	-	7 years (subject to 3 years in the second post, and also subject further to a minimum of 5 years in the Centre.)
AS level	-	4 years
Secy level	-	no ceiling.

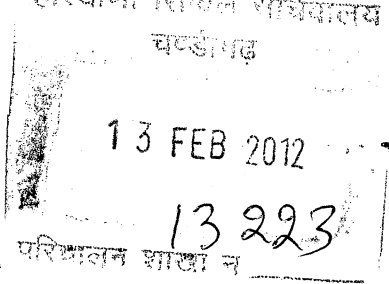
