The IAS Officers from 1981 to 2001 batches are eligible to attend the one-week

in-service training programme this year. Officers at the levels of Deputy Secretary / Director / Joint Secretary in the Central Ministries/Departments, who are posted under the Central Staffing Scheme, are also eligible to attend a one-week training programme.

 I enclose herewith the calendar of the one-week in-service training programmes available for the year 2011-2012 (Annexure-I). I request that the calendar may kindly be circulated among the eligible IAS Officers in your State.
