

TRAINING CIRCULAR

Subject: A Group Training Course in Information Management Technology for Land Use and Natural Resources Analysis to be held in Japan from 21<sup>st</sup> August, 2012 to 22<sup>nd</sup> September, 2012.

The undersigned is directed to state that the Japan International Cooperation Agency (JICA) under the Technical Cooperation of the Government of Japan has invited applications for the above programme to be held from July 2012 to December 2012 out of which the core phase would be held in Japan from 21st August, 2012 to 22nd September, 2012.

2. The programme aims to contribute to the improvement of quality and technology related with management of land use and natural resources in developing countries. In particular, it aims to introduce FOSS-GIS (Free and Open Source Software – Geographic Information Systems) to the management of land use and natural resources for reducing its managing cost.
3. The candidate should be university staff or institute researcher in the field of agriculture and/or environmental sciences who is engaged in teaching or research on information management technology for land use and natural resources analysis or officials who are engaged in policy making for information management technology for land use and natural resources analysis at the Central or local governments with over 5 years of experience; having experiences of using at least proprietary GIS software and be in a position to disseminate GIS technology at/in their respective office/country; be a graduate of university, not be serving in the military; be under the age of 40 years at the beginning of training course; be proficient in written and spoken English; be in good health to undergo the above training.
4. The course covers the cost of a round- trip air ticket between an international airport designated by JICA; travel insurance from the time of arrival in Japan to departure from Japan; allowances for (accommodation, living expenses, outfit and shipping); expenses for JICA study tours and free medical care for participants who may fall ill after reaching Japan (costs relating to pre-existing illness, pregnancy, or dental treatment is not included). The participants are not allowed to take any family member during the training course.


