
Sir/Madam,

3. It is therefore, requested that these instructions may be complied with strictly accordingly.



Subj: Hiring of private accommodation for government offices at Chandigarh.

Sir,

I am directed to refer to you to Haryana Govt. Letter No. 1503-Ad. C-71/14001, dated 9.6.71 on the subject cited above in which it was laid down that before hiring or private accommodation at Chandigarh, the prior approval of the Chief Secretary (Administrative Officer's Branch) is necessary and to say that the Government has now decided that in the case of new offices which are proposed to be opened in public interest at Chandigarh, the concerned departments should try for office accommodation at Panchkula. Office accommodation at Chandigarh should be looked for only if a certificate of non-availability is obtained from the Chief Administrator, Haryana Urban Development Authority. It is, therefore, requested that proposals for issue of non-accommodation certificate in connection with the hiring of private accommodation for Government offices at Chandigarh should be referred to this department only after obtaining a non-availability certificate from the Chief Administrator, Haryana Urban Development Authority.

2. It has further been decided by the Government that each department should consider if it will be in the interest of efficient working to shift any of its existing offices in Chandigarh to district headquarters. Approval should be obtained in each case from the Chief Minister.

3. It is requested that further action in the matter may please be taken accordingly.

Sub: Change in the procedure of renewal of Non-Availability Certificates for hiring private accommodation for Government offices at Chandigarh/Panchkula.

Sir,

I am directed to refer you to Haryana Govt. letters No. 1503-3Ad.O-71/14001, dated, 9.6.71 No. 3721-140.0-74/334, dated, 9.1.75, & No. 21/43/78-Ad.O., dated, 29.4.78, on the subject cited above in which it was laid down that before hiring a private building for office use in Chandigarh/Panchkula, the department concerned shall obtain prior approval/NAC from the Chief Secretary (In Ad.O. Branch) after having obtained the NAC from the Chief Administrator, HUDA, Panchkula. It was also laid down that the departments which have hired private buildings for office use in Chandigarh/Panchkula have to get the NAC renewed from Chief Secretary (In Ad.O. Branch) every year.


2. With a view to simplifying this procedure Government have reconsidered the matter and it has now been decided to discontinue the practice of getting approval for renewal of NAC every year in cases where there is no change of building and rent. The NAC shall, however, be required ^{to be obtained as heretofore} where a private building is hired for the first time or there is change of building or increase in rent.

3. It has also been decided that in future if any Govt. building is constructed or vacated in Chandigarh/Panchkula, the PWD (B&R) will send full description of the building to the Chief Secretary (In Ad.O. Branch) for being circulated to all the departments which are housing their offices in the private rented buildings at Chandigarh/Panchkula for making use of that building.

4. This issues with the concurrence of F.D. received vide their U.O. No. 10/17/90-2FICW, dated, 26.6.90.


