2. The Govt. of Haryana has decided to grant cash award & annuity to the awardees of Sena Medal, Distinguished Service/Devotion to duty, who got the award on or after 31.3.2008 and prior to 19.2.2014. One time cash award to the Sena Medal, Distinguished service / Devotion to duty, awardees of the Defence forces personnel who got the award on or after 19.2.2014. The amount shown below will be given as under:-


**ANNEXURE 'A'**

No.28/2/2005-4D-III

**Eligibility criteria for the cash award & annuity and one time cash award to the awardees of Sena Medal Distinguished service/ Devotion to duty.**

1. All ranks in the Army, Navy, Air Force, will be eligible.
2. In the case of awardees who could not claim/receive one time cash award for the awards in their life time, widow / parents will be eligible for one time cash award on 50:50: basis 50% to parents and 50% to the widow provided she does not re-marry after the death of the awardees. If the award is given posthumously the parents as well as the widow of awardees as mentioned above are entitled accordingly.
3. In case the awardee dies unmarried parents of the awardee are entitled to get the 100% award money in equal share 50: 50: basis (Step Mother and Step Father shall not be entitled to get the award money). If the parents are not alive widow is entitled for 100% award money. If the award is given posthumously the parents as well as the widow of awardees as mentioned above are entitled accordingly.
4. No other family members will be entitled to get the award money.
5. One time cash award will not be admissible if such grant has been given by any other State Government to the awardees for that particular award.
6. The recipients will be entitled to one time cash award on production of Domicile Certificate /Resident Certificate issued by competent authority of Haryana and attested copy of Ration Card.
7. The awardee must be a permanent domicile of Haryana State at the time of joining service and continue to be the permanent domicile of Haryana State at the time of award and continue to be domicile of Haryana till the date. A certificate in this regard should be obtained from competent authority of A.G.Branch Integrated H.O. MOD (Army, Navy & Air Force)
8. The awardee must apply for sanction of the awards with in three years of the Gazette Notification of the award medal, there after it will be time barred.
9. The awardees who received the award on or after 19.2.2014 are only entitled for one time cash award and they are not entitled for annuity and other benefits.
10. The awardees who received the Sena Medal distinguished service/devotion to duty award on or after 31.3.2008 before 19.2.2014 should also apply within three years. Thereafter all cases will be time barred.
11. Annuity shall be discontinued in respect of such awardees who are no more domicile of Haryana on the date of payment of annuity yearly.
12. No arrears of annuity will be paid.
