Kindly refer to this office memo No. 24/9/97-4D-III dated 16.12.2004, 05.04.2007 and 28.5.2014 on the subject cited above.

2. The State Government has decided to increase the rates of Financial Assistance(F.A) to the Blind ESM who are not in receipt of any pension/financial Assistance to the Blind ESM from Rs. 1500/- to 3000/- per month w.e.f 1.11.2016. There will be annual increase of Rs. 400/-per year every year w.e.f. 1.11.2017.

3. All other terms and condition for grant of Financial Assistance to the Blind ESM who are not in receipt of any pension/F.A will remain unchanged.

4. The expenditure will be debited to Major Head "2235-SSW-60-OSSWP-200-OP-(86) FA to Blind ESM-09-GIA (Non-Plan) Demand No. 22.

5. THESE INSTRUCTIONS WILL COME INTO FORCE W.E.F. 1.11.2016.
