

Subject:- Revised Policy/instructions regarding mode of Payment of ex-gratia grant to the families of Armed Forces Personnel (Army, Navy & Air Force) belonging to Haryana State killed in war/operation, in operational area, terrorist activities and natural calamities etc.

....
The State Government of Haryana has decided to change the mode of payment to the next of Kins of martyr/ causality of Armed Forces Personnel (Army, Navy & Air Force), who die in harness in the performance of their bonafide official duties while serving in operational areas/ in war / terrorist or Militant attacks / border Skirmishes and United Nation Peace Keeping Force etc.

The distribution of Ex-gratia grant mentioned in policies No. 13/8/92-4D-III dated 30.09.1999, and 7.11.2001 policy No.21/1/1997-4D-III dated 15.6.2001, policy No. 21/1/1997-4D-III dated 16.1.2015, policy No. 21/1/1997-4D-III dated 2.8.2016 and policy No. 20/28/1985-4D-III dated 13.10.2016 have been superseded and will be as under :-


1. (a) **70% to the Widow and Children-further distribution as under:-**
 - i) 35% to the Widow
 - ii) 35% to be equally apportioned among the unmarried Children
- (b) **30% to the parents with further distribution as under:-**
 - (i) 15% to the Father
 - (ii) 15% to the Mother
2. It is further clarified as below:-
 - (a) In case either of the parents is alive the 30% of Ex-gratia amount is to be released to him/her as the case may be.
 - (b) In case both parents are not alive the whole amount of Ex-gratia will be released to the widow and children.
 - (c) Where the deceased personnel was not married, 100% of the grant will be released to parents.
 - (d) In case of Father/Mother being no more or there being no unmarried children their respective shares should go to the widow.
 - (e) In case the deceased personnel did not have any children then the share of children would be equally distributed between widow and parents of the martyr.
3. All other terms and conditions mentioned in above policy shall remain unchanged.
4. All payments would be made through RTGS in Aadhar linked bank accounts of the beneficiaries.
5. This issues with concurrence of Finance Department conveyed vide their U.O. No. 3/9/2017- 1F.G.II/29666 dated 23/24.11.2017
