Subject: Prior consultation with Haryana Staff Selection Commission not required in case of promotion from Group D to Group C posts.

Sir/Madam,


I am directed to invite your attention to the subject cited above and to say that vide Government Notification bearing No. G.S.R.88/Const./Art/309/73 dated 29th June, 1973 Para 6 of the original notification dated 28.01.1970 which contains the list of functions of Haryana Staff Selection Commission. In para (b) of the list of functions, it was specified that cases pertaining to promotion and transfer from one service or post to another service or post pertaining to Group C & D would be consulted with the HSSC. Further, in the proviso to Para 6 it has also been mentioned that it shall not be necessary to consult the Board (now HSSC) in respect of such posts and matters as the State Government may by notification, specify.

2. In view of above regarding prior consultation with HSSC at the time of filling up the posts of Group C by promotion amongst Group D employees the instructions listed at Annexure A were also issued by Government from time to time.

3. Now on reconsideration, Government has decided that in future the case of promotion from Group D post to Group C posts shall not be consulted with HSSC.

4. These instructions are being issued in supersession of all the previous instructions listed at Annexure A. These may please be brought to the notice of all concerned.


