**Sir/Madam,**


I am directed to invite your attention to Government letter of even number dated 10.11.2020 vide which it was decided that the services of Group D employees who did not produce their Sports Gradation Certificate upto 31.12.2020 under the Sports Policy dated 25.05.2018 would be terminated with immediate effect.

2. Now the posts vacated by the selected candidates of sports quota due to non-production of valid Sports Gradation Certificate upto 31.12.2020 or due to resignation from service or non-joining within the prescribed period are to be filled up amongst the eligible candidates of sports quota from the waiting list. For this purpose they have to produce Sports Gradation Certificate under the Sports Policy dated 25.05.2018 to be issued by the Sports Department Haryana.

3. In view of above it has been decided that validity of waiting list is extended by 31.12.2021. Further, Sports Department is directed to issue Sports Gradation Certificate to the candidates of waiting list of Group D posts reserved for sports quota before 31.10.2021 and eligible candidates will submit their valid certificate by 30.11.2021.

4. These instructions may be brought to the notice of all concerned for strict compliance in letter and in spirit.
