- 5. The instructions issued by Haryana Government vide No 2311-1-GS-1-72/5727, dated, the 26-5-72, 5024-1 GS-1-72/26877, dated 8-9-72 and 2637-5 GSI-76/12144, dated 17.5.76 are hereby deemed to have been modified to this extent, so far as these relates to the S.S.S. Board.
