I am directed to refer to the instructions contained in Haryana Govt. letters Nos. 5663-4GSI-73/26498 dated 23/24-10-73, 5846-4GSI-74/27622, dated 22-11-74 and 3575-4GSI-75/24237, dated 9-8-75 on the subject noted above in which it was laid down that as far as integrity of an employee is concerned, the record of his whole career should be taked into consideration while considering the cases of Government employee for retedtion in Government Service beyond the age of 50/55 years. The matter has further been considered by the State Government and it has been decided that while coosidering the cases of retention in service beyord the age of 50/55 years, the reports of doubtfull integrity of an employee pertaining to the period beyond the last ten years, may be ignored. However, the instructions regarding placing the cases of those employees whose integrity has been suspect within this period will continue to be inforce and such cases would be placed before the Officers' Committee consisting of the Chief Secretary to Government Haryana, the Financial Commissioner, the Administrative Secretary and Head of Department concerned.

These instructions may kindly be brought to the notice of all concerned for compliance.
