Office bearers of sports associations- Clarification regarding.

Sir,

am directed to refer to the subject noted and to say that it has been observed by the State Government that several officers are holding positions in more than one association at the cost of official work. There are instances where for the same sports or game, parallel associations been floated by the officers and there is an intense rivalry bad blood among those associations each of which claims to genunine association. Furthermore, the officers of the Sports Department belonging to a certain discipline hold 10 associations relating to other disciplines. For instance, a kabaddi coach may be holding a position in Athletics Association or Volley Ball Association. This tendency needs to curbed with a heavy hand and discipline has to be ensured interest of official work and sports promotion in a the manner.

In All India Services (Conduct) Rules, 1968 which are applicable to the officers belonging to IAS/IPS IFS, there are regulatory provisions for such participation. Officers belonging to those services are required to take prior permission of the Government in case they want to hold an elective office

and also inform the Government about their participation if they are taking part in a non elective organisation.

The issue of framing guidelines in respect of officers/ officials of the State Government holding positions in various sports organisations was engaging the attention of the State Government for some time past. After careful consideration of the matter, it has now been decided by the State Government that no Government officer/official will be a member/ office bearer of more than one sports association at State level and one at National level. Accordingly, necessary provision has also been incorporated in the Punjab Government Employees (Conduct) Rules, 1966, as applicable to the State of Haryana, a copy of which is appended herewith, with the request that this may be brought to the notice of all officers/officials working under your control for their information and compliance.

- No. G.S.R. (A)/Const./Art. 187, 309 and 318/2000.—In exercise of the powers conferred by the proviso to article 309 and clause (b) of article 318 read with clause (3) of article 187 of the Constitution of India, the Governor of Haryana, after consultation with the Speaker of Haryana Legislative Assembly, in so far as such consultation is necessary under the aforesaid provisions, hereby makes the following rules further to amend the Punjab Government Employees (Conduct) Rules, 1966, in their application to the State of Haryana, namely:—
- These rules may be called the Punjab Government Employees (Conduct) Haryana Amendment Rules, 2000.
- 2. In the Punjab Government Employees (Conduct) Rules, 1965, after rule 6, the following rule shall be inserted, namely :-
 - "6A.—Limit to be a member/office bearer of sports association.—No Government employee will be a member/office bearer of more than one such association at State level and one at National level the aims or objectives of which relate to promotion of sports. Furthermore, the employees of the Sports Department may become member/office bearer of only one association at State level and one at National Level that too in the area of their own speciality/discipline.".

 2000, कहें जा सकते हैं।
- 2. पंजाब सरकार, कमंचारी (ब्राचरण) नियम, 1966 में, नियम 6 के बाद, निम्नलिखित नियम रखा जाएगा, अर्थात्:—
 - "6 क. खेल संघों के सदस्य/पदाधिकारी बनने की सीमा:— कोई भी सरकारी कर्मचारी ऐसे किसी एक से अधिक संघ का राज्य स्तर पर स्वा राष्ट्रीय स्तर पर एक से अधिक का सदस्य/पदाधिकारी नहीं होगा जिसके लक्ष्य या उद्देश्य खेलों की तरक्की से सम्बन्धित हों। इसके अतिरिक्त खेल विभाग के कर्मचारी राज्य स्तर पर कैंवल किसी एक संघ के तथा राष्ट्रीय स्तर पर केंवल एक के सदस्य/पदाधिकारी बन सकते हैं और बढ़ भी केंवल अपनी विविष्टता/शिक्षा के क्षेत्र में।"।
