Subject:- Ban on adhod promotion against direct quota posts/vacancies.

: :

Sir,

I am directed to invite your attention to instructions contained in Finance Department's circular letter No. 5/16/2000-18%C, dated 16.3.2000 regarding ban on fresh recruitment/ creation/upgradation of bosts. Under these instructions, there is a complete ban on all new recruitment from Groups-I to Group-IV posts with the exemptions depicted therein. These instructions also provide that all posts lying vacant for more than two years as on 29.02.2000 shall stand abolished.

However, it has been prought to the notice of the Government that very often adhoc promotions are made against vacancies to be filled by direct recruitment by the departments. Such an action completely negates the ban on recruitment as well as instructions about abolition of posts lying vacant for more than two years. It also creates vested interest of the adnocation appoints as promotes.

The State Government has viewed seriously this tendency the part of the departments. After careful consideration of the matter the Sovernment has decided to ban promotions against direct recruitment quota in all Groups forthwith.

I am, therefore, to request that these instructions should be brought to the notice of all concerned for being ' complied within their letter and spirited to a design dear
