Subject:- Amendment of policy regarding regularization of adhoc/contractual and daily wage employees.

Sir,

I am directed to refer to Haryana Government letter No. 6/9/2003-IGSI, dated 22.10.2003 and even number dated 11.02.2004, on the subject noted above and to inform that the State Government had formulated the policy for regularisation of adhoc/contractual and daily wage employees vide notification No. G.S.R. 24/Const./Article 309/2003, dated 1st October, 2003, wherein clarification was sought by departments of the Government regarding creation of posts for regularising the services of daily wage employees of Group 'C' and Group 'D'.

It is clarified that only such daily wagers who had been engaged before 31.01.1996 and who have completed three years service on Group 'C' or Group 'D'

If the posts are not available, they should be got created from the Finance Department with effect from 01.10.2003.

This may please be brought to the notice of all concerned.
