Subject: Ban on transfers.

Sir,

Vide Haryana Government letter No. 45/4/96-ICSI, dated 17th July, 1996, a ban was imposed on transfer of the Govt. employees. These instructions were re-iterated on 1.10.96 wherein Administrative Secretaries and Head of Departments were requested to ensure that no transfer orders would issue without specific prior approval of the Chief Minister.

2. It has been brought to the notice of the Government that some departments are changing Headquarters of their officials on 3-4 months basis. It has become another way of making transfers, which is violation of the above cited orders of the Government.

3. The Government has decided that this practice should be stopped immediately. Heads of Departments are requested to prepare a list of all such orders issued and send the same to General Administration Department within a week of

Government have re-examined the matter and after in future this relaxation in tenure beyond five years shall be admissible to only such employees as are due to retire within one year (repeat one year). In other words this maximum period of the five years shall also not apply to Government employees both gazetted and non gazetted, who are due to retire

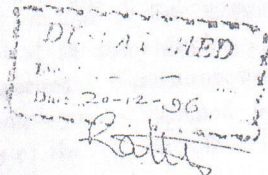
