Subject: Reservation for Special Backward Classes.

Sir/Madam,

I am directed to invite your attention on the subject noted above and to say that vide letter dated 5.3.2019 (Memo No. 22/149/2015-1GS-III) Government had directed that in cases of all recruitment advertisements where result of Special Backward Classes was put on hold due to Court orders, the HPSC/HSSC shall treat the Special Backward Classes posts to be under the General/Unreserved category. Also, where there is no court stay, yet result was withheld, the HPSC/HSSC shall treat the Special Backward Classes posts to be under the General/Unreserved category. Upon reconsideration, the said letter is hereby withdrawn.

1. The Special Backward Classes reservation was withdrawn vide instruction dated 1.4.2016 (Memo No. 22/140/2015-1GS-III) and after this date the Backward Classes Block "C" reservation came into effect.
2. The State Government has considered the matter and prescribes as below:
 - a) In respect of all recruitment advertisements where result of Special Backward Classes was put on hold due to Court orders, the HPSC/HSSC shall treat the Special Backward Classes posts to be under the General/Unreserved category.
 - b) In respect of all recruitment advertisements where there is no court stay on the results, yet result was withheld, the HPSC/ HSSC shall treat the Special Backward Classes posts to be under the General/Unreserved category.
 - c) In case Departments/Boards/Corporations had with-held posts of Special Backward Classes, such posts may be released and requisition for such posts may be sent to appropriate recruitment authority, treating such withheld posts to be under the General/Unreserved category.
3. The above directions may be brought to the notice of all concerned for strict compliance.


