To

I am Directed to refer to the subject noted above and to say that it has been brought to the notice of the Govt. that some persons professing religion other than Scheduled Castes/Scheduled Tribes had managed to secure Scheduled Castes Certificates on the plea that their caste found a place in the Presidential orders notifying the Scheduled Castes and Schedule Tribes. This has resulted in some persons availing the benefits meant for Scheduled Castes and Scheduled Tribes on false pretexts. After careful consideration it is hereby clarified that a Scheduled Castes Certificate con be issued in favour of persons prefessing Hindu or Sikh religion only.

Receipt of this letter may please be at movied ed.

Similarly, there were instances where some of the persons had get the Caste Certificates on the basis of their marriage to a spouse belonging to Scheduled Castes/Scheduled Tribes. According to the guiding principles, the status of a persons not belonging to Scheduled Caste/Scheduled Tribe is not changed by virtue of his/her marriage to a person belonging to Scheduled Caste/Scheduled Tribes. So. it is also clarified that while issueing such a certificate, these instructions may strictly to adhered to.
