August, 1983 on the subject noted above and to say that the form of Scheduled Castes/Scheduled Tribes certificate enclosed with the aforesaid letter for migrated persons has been further revised consequent upon coming into force of the Scheduled Castes and Scheduled Tribes orders (Amendment) Act, 1976 and kepping in view the difficulty being experienced by the persons belonging to Scheduled Castes and Scheduled Tribes in obtaining community certificates on migration from their States of origin to another for the purpose of employment education etc. the revised caste/tribe from of certificate is enclosed herewith which will be applicable to both migrated as well as State domicile person. The instructions issued by the State Govt. from time to time on the subject regarding proper verification will continues. It is however clarified that the Scheduled Castes/Scheduled Tribes persons on migration from the state of his origin to another state will not less his status as Scheduled Castes/ Scheduled Tribes but he will be entitled to the concessions/benefits admissible to the Scheduled Castes/ Scheduled Tribes from the State of his origin and not from the state where he has migrated.

2. All the competent authorities in the State are hereby advised to issue the Scheduled Castes/ Scheduled Tribes certificates on the revised form which will be applicable for both state as well as migrated persons hendeforth after satisfying themselves of correctness of the certificate after proper verification based on average records. The list of the competent authorities empowered and incorporated the form may please be followed strictly.
