Streamlining the procedure in the offices regarding issuing of Castes Certificates to Scheduled Castes, Backward Classes and Other Backward Classes.

Sir/ Madam,

I am directed to invite your attention to the Government letter No. 22/76/2012-1GSIII, dated 22.3.2012, vide which proformae of caste certificates devised by the Government were sent for the purpose of issuing caste certificates to the Schedules Castes/Backward Classes/Other Backward Classes to the employees of Haryana Government, residents of Haryana as well as to the persons who have migrated from other States. However, certificates to the migrants were to be issued subject to the production of a genuine certificate issued to his father by the prescribed authority of the State of his father's origin except where the prescribed authority feels that a detailed enquiry is necessary through the State of origin before the issue of the certificate.

The matter has been further examined and it is felt that it will not be possible for the State to verify each caste certificate of the candidates who have migrated from other States/UTs to the State of Haryana. Besides it will create inconvenience to the candidate as well as to issuing authority of Haryana Government. Hence, it has been decided that caste certificates should be issued only to the employees of Haryana Government and to the residents of Haryana. A copy each of the revised Proformae is also enclosed.

These instructions may be brought to the notice of all concerned for strict compliance.
