

(1) This Act may be called the Haryana Contractual Employees (Security of Service) Amendment Act, 2025.</p> <p>(2) It shall be deemed to have come into force with effect from the 31st January, 2025.</p> <p>2. In Explanation 2 to clause (ii) of section 3 of the Haryana Contractual Employees (Security of Service) Act, 2024, for the words “in a calendar year”, the words “during a period of one year contractual service” shall be substituted.</p> <p>3.
