

**Subject: - Regarding to provide the number of vacancies for the posts of Clerks.**

Sir/Madam,

I am directed to invite your attention on the subject cited above and to inform you that Hon'ble Punjab and Haryana High Court passed the following orders on 15.05.2024 in CM No. 4513 of 2023 in LPA under 1692 of 2023 titled as Suman Devi vs. State of Haryana and others:-

10. *In such circumstances, we deem it appropriate to direct the State Government to file an affidavit as to what are the numbers of vacancies available for the posts of Clerks as on today in various Departments/ Boards/ Corporations and Public Undertakings. State Government shall also file an affidavit as to whether the appellants who were initially appointed have been continuing by virtue of the interim orders granted by this Court can be adjusted against the vacant posts keeping in view the peculiar facts and circumstances without as such impinging upon the vested rights of any other candidates.*
2. In compliance of above orders of Hon'ble High Court, Government has decided to seek the information of vacancies for the post of Clerks in various Departments/Boards/Corporations etc. Therefore, all Administrative Secretaries to Government Haryana are requested to direct the head of Departments/Boards/Corporations etc. under your control to provide the compiled number of vacancies available for the posts of Clerks in your department(s)/Board(s)/Corporations etc. through special messenger or email i.e. [superintendentgs2@gmail.com](mailto:superintendentgs2@gmail.com). The CM No. 4543 of 2023 in LPA No. 1692 of 2023 is **fixed for hearing on 24.09.2024**.
