Subject:- Grant of reservation to Outstanding Sports Persons (OSP) and Eligible Sports Persons (ESP) against Group C posts.

Sir/Madam,

I am directed to invite your kind attention towards the Government's instruction bearing No.22/10/2013-1HR-III and No.22/10/2013-5HR-III, dated 24.11.2022 and dated 27.04.2023 respectively on the subject cited above and to say that the State Government has reconsidered above referred instructions and decided to grant a separate quota of 3% to eligible Outstanding Sports Persons (OSP) and Eligible Sports Persons (ESP) (3% of total C posts recruited by the Haryana Staff Selection Commission (HSSC) in any given year). For this purpose of the Sports & Youth Affairs Department, Haryana shall create a separate quota and send a requisition to Haryana Staff Selection Commission (HSSC) for a separate recruitment drive for Outstanding Sports Persons (OSP) and Eligible Sports Persons (ESP) to the tune of 3% of total Group 'C' posts recruited by the Haryana Staff Selection Commission (HSSC) in any given year. These quota will exist within selected few departments, namely:-

- 1) Home Department.
- 2) Sports Department.
- 3) School Education Department.
- 4) Elementary Education Department.
- 5) Jail Department.
- 6) Forest & Wildlife Department.
- 7) Energy Department.
- 2. Thus while the calculation of number of such posts will be as 3% of total Group 'C' posts recruited by the Haryana Staff Selection Commission, these posts will be advertised only for above mentioned departments.
- 3. Within this separate quota (of 3% of Group 'C' posts recruited by HSSC in a given year) for Outstanding Sports Persons (OSP) and Eligible Sports Persons (ESP) first

preference will be given to Outstanding Sports Persons (OSP) appointed to Group 'C' posts under the Notification No. G.S.R. 4/Const./Art. 309/2021, dated 26.02.2021 issued by Sports & Youth Affairs Department, Haryana namely the "Haryana Outstanding Sportspersons (Group A, B, and C) Service Rules, 2021".

- Once the candidates appointed to Group 'C' posts under Haryana Outstanding Sportspersons (Group A, B and C) Service Rules, 2021 have been accounted for, for the remaining posts in this separate quota (of 3% of Group 'C' posts recruited by HSSC in a given year), the Sports Department, Haryana shall create a separate roster register for these posts as per the existing instructions of Government of Haryana at the time, and also send a requisition to HSSC to be recruited separately by a selection process in which only Outstanding Sports Persons (OSP) and Eligible Sports Persons (ESP) candidates will be allowed to apply.
- 5. For the purpose of these instructions, "ESP" means a person who has obtained a Sports Gradation Certificate of Grade 'C' or above under Sports Department, Haryana's Notification dated 25.05.2018 or as amended from time to time.
- 6. Above referred instructions No. No.22/10/2013-1HR-III and No.22/10/2013-5HR-III, dated 24.11.2022 and dated 27.04.2023 respectively are hereby superseded.
- 7. These instructions may please be brought to the notice of all concerned for strict compliance.
