Haryana Govt. Employees Group Insurance Scheme, 1985-Increase in the rate of subscription and Insurance cover effective from 1.1.1990- Rate of premium for new entrants in Govt. service.

Sir,

I am directed to invite your attention to Haryana Govt. letter No. 1/5/89-1 NGIS dated 13/10/89 wherein 5.0% increase in the rate of subscription and the corresponding insurance cover under the Group Insurance Scheme has been made with effect from 1st January, 1990. In para 6 of the notification dated 20/8/1985, it has been stated that the employees entering service in a month other than April (month of start of the Scheme) falling after the 1.4.86 will be given benefit of appropriate insurance cover from the date of joining the Govt. service to the date of their becoming members of the Scheme on payment of Rs.3/- per month as the premium for every Rs. 10,000 of the insurance cover.

2. Now due to the enhancement in the rate of subscription and insurance cover it has also been decided by the Haryana Govt. that in modification of the provision in para 6 of the updated Scheme the employees entering service on or after

subscription of Rs.5/- per month as the premium for every
 15000/- of the insurance cover. Therefore, the new rate
 subscription of Rs.15.00 per unit is apportioned into 5:10
 providing insurance cover of Rs. 1,20,000/- , Rs.60,000/-,
 30,000/- and Rs. 15,000/- to Group 'A', 'B', 'C' and 'D'
 employees respectively during the year of their entry to Govt.
 service (if they enter Govt. service on or after 2nd January
 any year they will pay subscription at the rate of Rs.40/-
 20/-, Rs.10/- and Rs.5/- per month respectively as the
 premium from the month of entry to Govt. service till 31st
 December of that year.

You are, therefore, requested that the contents of
 this letter may kindly be brought to the notice of all employees
 of the Haryana State and within the Departments under your
 administrative control.

Necessary amendments in the relevant rules will be
 made in due course.
