2. I am, therefore, directed to say that the State Government authorises the Deputy Commissioner of the District to effect the change after considering the matter as and when any Gram Panchayat/Municipal Council etc. approaches him with a resolution in this regard.

I am directed to refer to this department letter of even number dated 17.07.1999 on the subject noted above and to state that vide aforesaid letter a policy was framed as under:-

Keeping this in view and with a view to boost the morale of the Forces, the State Govt. has decided that the Government/aided Educational Institutions in the cities/Towns/Villages may be named after such martyrs belonging to those cities/Towns/ Villages who have laid down their lives for defending the motherland during 'Operation Vijay' in Kargil." The State government authorized the Deputy Commissioner of the district to effect the change after considering the matter as and when any Gram Panchayat /Municipal Council etc. approached him with a resolution in this regard."

Now, it has been decided that besides above, the other martyrs, the freedom fighters or eminent personalities who have been awarded national award may be included in the said policy and action may be taken accordingly.



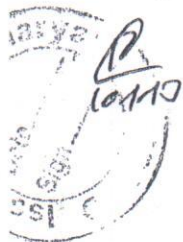
