Sir,

I am directed to address you on the subject noted above and to say that keeping in view the proposed Jat Agitation scheduled from 29.01.2017, the situation needs to be maintained closely, for which the following steps may be undertaken immediately:-

- i) People contact programme be undertaken by all DCs, CPs and SPs in wake of the call for agitation to ensure peace and harmony in the State.
- ii) All major critical points like installations of drinking water supply to Delhi in Karnal and Sonipat, traffic movement on the G.T. Road, Roadways depots, etc. should be secured.
- iii) All departments shall secure their own installations and services with the assistance of their own staff, and the police, where required.

District Administration shall make preparations to deal with the situation and ensure that law and order is maintained. Divisional Commissioners and Deputy Commissioners are requested that Situation Reports relating to their Division/District be sent to CS Office with effect from 24.1.2017 till further orders at 2.00 PM daily, in the enclosed proforma.
