





Cabinet Secretariat vide their communication No. 191/20/1/2014-TS dated March 8, 2017 has advised this Ministry to sensitize all the addressees regarding the proposed international conference on the One Belt and One Road also known as Belt and Road Initiative which is being held by China in Beijing on May 14 - 16, 2017.

2. Government of India's concerns on this initiative, since it includes the so-called China-Pakistan Economic Corridor (CPEC) which passes through Indian Territory under illegal occupation of Pakistan, are well known and have been expressed in response to Parliament Questions. These concerns relate to India's sovereignty and territorial integrity.

3. The concerned Ministries/Departments are requested to ensure that any proposal for participation in the above international conference by Government officials and officials working in Public Sector Undertakings and Autonomous Institutions which require approval of the concerned Ministries/Departments are referred to this Ministry. It is important that due supervision is maintained so that no clearances are granted without political clearance of this Ministry.
