



Subject:- Regarding increase in the fixed medical allowance of the Freedom Fighters/their widows belonging to Haryana State from Rs. 250/- to Rs. 750/- per month.

In continuation of the Haryana Government Memo No. 15/142/89-4PP dated 11.12.08 on the subject cited above:

2. Sanction of Governor of Haryana is hereby accorded to the increase of the fixed medical allowance of Freedom Fighters/their Widows belonging to Haryana State from Rs. 250/- to 750/- per month with immediate effect.

3. Accordingly, the onward payment of Samman Pension to the Freedom Fighters/their Widows belonging to Haryana State may be made at the rate of Rs. 6000/- per month (including fixed medical allowance @ 750/- per month) with immediate effect.
