Subject: - Grant of Financial Assistance to the Haryana State Freedom Fighters/INA Personnel and their widows for the marriage of their grand-daughters.

Sir/Madam,

In continuation of the Government letter of even number dated 15/03/1984, 26/06/1984, 24/02/2006, 20/08/2009 (substituted on 01/10/2015), 25/03/2010, 30/08/2010 and 08/03/2016, I am directed to refer to the subject noted above and to inform that the Government has introduced the financial assistance scheme @ Rs. 2000/- to the Haryana State Freedom Fighters/INA personnel and their widows for the marriage of their daughters and dependent sisters, vide Government letter of even number dated 26/06/1984. Subsequently, the Government revised financial assistance to Rs. 51000/- and further extended it to cover the marriage of their grand-daughters vide Government letter dated 20/08/2009. The State Government also clarified, vide the substituted order bearing even number and dated i.e. 20/08/2009, which was issued on 01.10.2015 that their son or daughter-in-law of the Haryana State Freedom Fighter/INA personnel can also apply the financial assistance for the marriage of his/her daughter being grand-daughter of freedom fighter, in case of the death of Haryana State Freedom Fighter/INA personnel and their widows.

2. However, it has been observed that State Government issued the latest instructions dated 08.03.2016 in which it is not clear that who can apply for the claim of financial assistance for the marriage of grand-daughter of freedom fighter in case of the death of Haryana State Freedom Fighter/INA personnel and their widows. Due to which, beneficiaries are facing many problems for obtaining the above said financial assistance.

3. Now, it has been decided to clarify that son or daughter-in-law of freedom fighter can also apply the financial assistance Rs. 51000/- for the marriage of his/her daughter(s) being grand-daughter of freedom fighter after the death of Haryana State Freedom Fighter/INA personnel and their widows.

4. The claim for the financial assistance for the marriage of daughter(s), dependent sister(s) or grand-daughter(s) of the Haryana State Freedom Fighters/INA personnel's and their widows Rs. 51000/- ordinarily be made within 6 months from the date of marriage but not later than 12 months (special reason to be recorded for any delay) through the concerned Deputy Commissioner.

5. The other terms and conditions will be the same as contained in para-2 of Haryana Government letter No. 49/16/4PP-82, dated 26.06.1986.


6. It is further reiterated that after verification of claims and recording his/her satisfaction, Deputy Commissioner will forward the case to Chief Secretary to Government, Haryana to issue sanction to the Administrator General and Official Trustee and Treasurer, Charitable Endowments Haryana for making the necessary arrangements for payment of the financial assistance.

7. It is also mandatory that financial assistance shall be provided through Aadhar linked bank accounts.

This issues with the approval of competent authority.
