Clarification regarding transfer of State Samman Pension after death of Freedom Fighters unmarried/widowed/divorced daughter and disabled unmarried or their unemployed sons.

· Sir/Madam,

I am directed to invite your kind attention to the subject noted above and to say that, in continuation of this Department's instructions dated 04.11.2024, to obviate any misinterpretation, it is hereby clarified that widowed daughter(s) (otherwise eligible) of the freedom fighter, shall be eligible to get the benefit of State Samman Pension on or after 04.11.2024 irrespective of the date on which she became widow. Hence, any widow daughter who applies for the pension on or after 04.11.2024, shall be granted the benefit of pension, provided she is otherwise eligible, irrespective of the date on which she became a widow.

This may be treated as a supplementary to the instructions dated 04.11.2024. All other terms and conditions contained in the said instructions shall remain unchanged.
