- I am directed to refer to the subject noted above and to say that the matter regarding transfer of State Samman Pension after death of a Freedom Fighter or their spouse to unemployed unmarried/widowed/ divorced daughters (provided widowed/divorced have no other income source) and disabled unmarried unemployed sons has been under consideration of the Government. It has now been decided that the State Government that in supersession of earliest instruction No. 49/24/2006-2PP, dated 12th June 2009, the Samman Pension after death of Freedom Fighters or their spouse be trar ferred further to their unemployed unmarried/widowed/divorced daughters and disabled anmarried unemployed sons with 75% disability with immediate effect. If there is more than one eligible child, they will get proportionate share in the pension.
