Copy of Ministry of Home Affairs Office Memorandum No. F. 56/50/54 Wats(B), dated the 25th September, 1954, addressed to all Ministries, etc.

Subjects - Candidates for employment in civil posts under the Government of India- Procedure for verification of character and antecedents.

The Home Department Office Hemorandum No. 20/58/45-Ests(S). dated the 7th Pebruary, 1947 (as modified by Ministry of Home Affairs' Office Memorandum No. 3/14/51-NGS-II, dated the 31st January 1952), lays down that in respect of Class I and Class II Services as well as certain specified categories of Class III and Class IV posts, no appointments should be made except after the character and antecedents of the candidate have been verified through the District Magistrate or Deputy Commissioner of the district or locality and the Deputy Inspector General, C.I.D., of the State in which he is permanently resident or has resided for more than a year within five years of the date of enquiry. Such verification is carried out by the District authorities through the agency of the local local enquiries in regard to the candidate. Such local enquiries consider are intended(a) to establish the candidate's identity, kex i.e. to police and it has been the practice for a police official to make verify whether he has given correct particulars regarding himself, and (b) to ascertain whether there are any facts known about him which would render him unsuitable for Government service. addition, the police, also consult their records to see whether he has a criminal record or has been engaged in or associated with others engaged in subversive activities etc. The Government of India consider that the interrogation of the candidate or others associated with him by police officials is neither necessary or desirable in the present circumstances, and should therefore be evoided. As regards the candidate's identity it has been decided that every candidate for employment in posts and services for which detailed perification has been prescribed, should furnish with his application a certificate from a gazatted officer of the Central or a State Government or a member of the Central or a State legislature or other similar trustworthy source who can certify from personal knowledge to the identity of the applicant and the correctness of the particulars furnished by him. The revised form of attestation forwarded herewith should be used for this purpose in place of Verification Roll attached to Ministry of Home Affairs' Office Memorandum No. 3/14/51-NGS, dated the 22md May, 1953. It is not considered necessary to make enquiries regarding the local reputation of the candidate and the police authorities should rely on the information available in their records to certify whether he has come to adverse notice or not.

It has also been decided that is instead of simultaneous references being made to the District Magistrete and the Deputy Inspector General, CID a reference should be made only to the Distt. Magistrate who should wak forward his report to the authority making the enquiry through the Deputy Inspector General, CID of the State.

All such detailed enquiries through local, authorities (where-they have been prescribed) should be completed before a formal offer of appointment is made to the candidate. Offers of appointment or provisional appointments, subject to verification of character and antecedents should not be made. Where appointments have already been made in the past without completing the verification of character and entecedents and it is found necessary to dispense with the services of the employee in view of the adverse reports received from the local authorities the fact that action is being taken on the x results of a police report should not be made known to the employee nor should the nature or substance of the reports received from the police be communicated under any circumstances to the employee.
