Subject: Decision dated 09.10.2023 of Hon'ble Supreme Court of India, in Writ Petition (Civil) No. 360 of 2021 titled as Kishan Chand Jain Vs. Union of India & others.

Sir/Madam,

I am directed to invite your kind attention to this office letter of even no. dated 09.11.2023 and subsequent reminder dated 15.11.2023 on the subject cited above, vide which it was requested to provide compiled list of email addresses of all State Public Information Officers working in your respective departments as per directive of the Hon'ble Supreme Court of India which is still awaited from all the Departments/Board/Corporations etc.

2. The Government has taken serious view of this lapse as the order of the Hon'ble Supreme Court is not taken seriously by the Departments/Boards/Corporations etc.. Consequently, the Government has decided that the requisite information must be sent in a compiled manner within the stipulated time period. If, any Departments/Board/Corporations etc. fails to do the needful, will be held responsible, for any adverse decision passed by the Hon'ble Supreme Court:-

- (i) Collect all the e-mail addresses of the SPIOs working in their Department, thereafter the Department shall compile the E-mail IDs in proper manner of all the SPIOs in single file at the Headquarter level and send to the Government.
- (ii) The soft copy (excel) of the requisite information should also be send to the Government and State Information Commission, Haryana.

3. Therefore, it is again requested to send the aforesaid information as per ibid points No. (i), (ii) to the Government and the State Information Commission, Haryana by 16.08.2024 upto 05:00 PM through email at the following e-mail address: **admnreformshry@gmail.com** and **cic@hry.nic.in/ussichry@yahoo.co.in.**
