Subject: Appointment of State Chief Information Commissioner and State Information Commissioners in the State Information Commission, Haryana.

The Government of Haryana has constituted a body under the Right to Information Act, 2005 (No. 22 of 2005) known as the Haryana State Information Commission to exercise the powers conferred on and to perform the functions assigned to it under the Act. The Commission is located in Panchkula.

2. It is proposed to fill up the following posts of the State Chief Information Commissioner and State Information Commissioners in the Haryana State Information Commission:

Sr. No.	Name of Post	No of post	Remarks
1.	State Chief Information Commissioner	One	Likely to be vacated on 25.3.2025
2.	State Information Commissioners	Seven	Six posts already vacant and one post is likely to be vacated on 25.3.2025

- 3. The Act provides that the State Chief Information Commissioner and State Information Commissioner:-
- (i) Shall be person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.
- (ii) Shall not be a Member of Parliament or Member of the Legislature of any State, or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business, or pursuing any profession. It is clarified that cessation/termination of holding of office of profit, pursuing any profession or carrying any business is a condition precedent to the appointment of a person as State Information Commissioner.
- 4. Person who have attained the age of 65 years shall not be eligible for appointment.
- 5. State Information Commissioner shall hold office for a period of three years from the date on which he enters upon his office or till he attains the age of 65 years, whichever is earlier.
- 6. The salary, allowances and other terms and conditions of service of the State Information Commissioner shall be as per the Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioner in the Central Information Commission, State Chief Information Commissioner and State Information Commissioner in the State Information Commission) Rules, 2019.
- Persons fulfilling the criteria for appointment and interested for appointment to the post of State Chief Information Commissioner and State Information Commissioner may send their particulars in the enclosed proforma only, by post to office of Secretary to Government of Haryana, General Administration Department, Room No. 44-A, 6<sup>th</sup> floor, Haryana Civil Secretariat, Sector-1, Chandigarh, latest by 21.03.2025 (up to 5.00 PM). Persons, who are serving under the State/Central Government or any other Organization, should send their particulars through proper channel.
